Library: R. Harn addressed the Council in regard to funding for the Westgate Library for 2023-2024. She stated the Library Board has come to the conclusion that more funding is needed as there has been no increase in funding for several years, not even to keep pace with inflation. The Board requests that Library funding be increased annually from \$7500.00 to \$10,900.00 with the inclusion of an increase in the wage of the Librarian from \$8.00/hour to \$9.00/hour. Or, if the wage were to remain at \$8.00/hour, the general funding from The City would still need to increase \$2000.00 just to cover current Library Staff wages without resorting to fundraising. It was emphasized that this increase was the first in many years and necessary to keep the number of open hours of the Library above the minimum to keep receiving state aid funds.

Mayor/City Clerk: T. Wild addressed the Council about a notice of how the City's electric franchise agreement with Alliant Energy is going to end in 2023 and will have to be renegotiated. She will look into this more.

Motion to adjourn meeting by E. Wolff and seconded by R. Moore. Motion passed. Council Meeting adjourned at 6:30pm.
